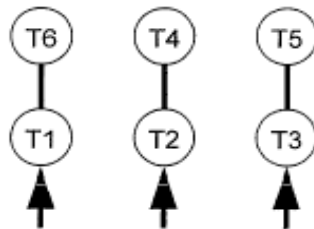

CONNECTION DIAGRAM



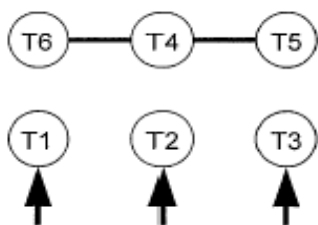
SCHEMATIC - Δ / Y CONNECTION

ACROSS THE LINE CONNECTION

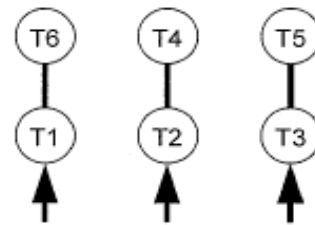


460 VOLT CONNECTION
